Rules

1. The client is responsible for the chair(s) from the time of drop off to the end of the event/pick up. Chairs will be inspected at both drop off and pick up to make sure that they are in good condition.
2. The client will provide valid credit card information for Paola's Party Land to keep on file. The client will also provide a valid NY State ID that matches the credit card information. Credit Cards are kept on file to be charged in the unlikely event of damage to any of the rental pieces.
3. If the client opts for delivery and pick up of the chair(s), Paola's Party Land will make the drop off at the scheduled time. The client agrees to be at the event location to accept responsibility of the chair(s). No drop offs will be made unless there is someone at the event location to take responsibility of the chair. We will not wait more than 15 minutes for the client. After that time, the chair will be returned to our warehouse and the client will forfeit all of his/her deposit.

4. If the client opts for pick up of the chair(s), Paola's Party Land will pick up the chair(s) at the scheduled time, but no later than 1:00am. We will pick up the chair even if the party is still going on.
5. The chair(s) is solely for the guest of honor to use. Children are not allowed to eat, drink or jump on them.
6. Please keep in mind that these chairs are expensive and need to be treated with care, as if you own them.
7. If we find any marks or stains, the client agrees to pay for the damage. The credit card on file will be billed \$50 and up depending on the extent of the stain. If the damage is irreparable, i.e. any tears on the fabric, broken pieces of wood, broken armrests, broken legs, water damage etc., the client agrees to pay the entire cost of the chair(s) as follows:
6' Diamond Tufted Chair: \$1,000
Porter Chair: \$800
Child's Diamond Tufted Chair: \$300
Royal Chair: \$300
8. We cannot take any furniture up the stairs.
9. We cannot rent the chair(s) for outside events. Rain will damage the chair(s) and we cannot take the risk.
10. If the client decides to pick up and return the chair(s) him/herself, the client agrees to pick up between the hours of 10am and 6pm the day of the event. The client also agrees to return the chair between the hours of 10am and 1pm the day following the event. If the rental is not returned, the client agrees to pay an additional \$75 per day.
11. Chairs will not be released if the car is not big enough to fit the chairs.
12. Deposits are non-refundable.
13. We don't share any credit card information with any third parties, nor do we charge the client's card for security deposits. The client's credit card will only be charged in the unlikely event of damage.

Payment

Payments may be made in cash or by credit card. We accept Visa and MasterCard only. We cannot take credit card payments over the phone. We require payment of 50% of the Total Cost of Service upon the signing of this contract. Final payment must be made the day before the event. If the client cannot make the Final Payment the day prior to the event, the client agrees to come to Paola's Party Land the day of the event to make the Final Payment in person before any deliveries are made. The chair(s) will not be delivered unless Final Payment is made. Deposits will be forfeited.

Cancellations

The client understands that reserving Paola's Party Land to be available for an extended amount of time on the day of the client's event limits the number of other events Paola's Party Land can serve the same day. The client also understands that the rental has been specifically set aside for his/her event. Therefore, all payments will be non-refundable.

The client authorizes the billing of his/her credit card for any damages the chair(s) incurs while in his/her care.
